New CITCSA Board member elected at AGM

Natasha Malani, President, Australia India Business Council, was newly elected to the CITCSA Board for 2010-2011 at the CITCSA AGM held on Wednesday September 29th.

Teo Spiniello, Secretary - General of Italian Chamber of Commerce and Leon Coppins, President of Thailand SA Business Council were re elected for 2 year terms. Kerry Lewis, President of Korean Chamber of Commerce, and Steve Marafiote from the Australia Arab Chamber of Commerce are the other two elected Board members who are serving the final year of their 2 year term. Appointed members on the CITCSA Board are Nick Begakis AM, Chairman, Pat Moessinger (Austrade), Wayne Parham (DTED) and David Frith (Business SA)

At the Annual General Meeting, CITCSA Chairman Mr Nick Begakis AM thanked each of the 40 ethnic business member organisations who have helped CITCSA collectively achieve its Key Performance Indicator goals for each of the past five years to deliver great outcomes for South Australia. This has been recognised by Hon Kevin Foley MP, our previous Minister for Industry and Trade, and DTED over the past five years.

Over the past year, CITCSA member organisations facilitated successful 13 outbound trade missions to Hong Kong, China, Latvia, Italy, Israel, Philippines, India, Singapore, and Vietnam, and hosted 6 valuable inbound trade missions from Thailand, China, Japan and

CITCSA had run 13 networking events including the CITCSA Awards Dinner, Minister's dinner for Presidents at Parliament House, and organised 4 export industry workshops on Events and marketing, export grants, trade missions and country specific briefings.

In a new initiative with the Adelaide City Council, CITCSA now manages the business relationships with the sister cities of the City of Adelaide being Christchurch (NZ), Himeji (Japan), Georgetown (Malaysia), Austin (USA) and now Ferrol (Spain). We do this by working closely with members of our respective member organisation for that country. We look forward to this partnership continuing on a longer term basis with appropriate funding.

CITCSA provided input into the Federal Governments Review of the Australian Citizenship Test and the process has now become more streamlined and the test more relevant and inclusive.

CITCSA successfully reapplied to maintain our status as an organisation that can sponsor business visitors under the sub class 459 visa program through the Department of Immigration and Citizenship.

The Chairman concluded his report by thanking the sponsors and supporters of CITCSA, its Board members and staff for their valuable contribution over the past year. He looked forward to 2010/2011 with continued enthusiasm as we move to a challenging year of change (the full CITCSA 2009/2010 Annual Report is available on the website www.citcsa.org.au)

The members present at the meeting spent considerable time discussing the future of CITCSA and funding options from July 1st 2011 when the funding from DTED via Business SA will be phased out.

It was acknowledged at the meeting that CITCSA started in 1994 as an initiative of former Labor Premier Lyn Arnold, and then former Liberal Premier Dean Brown, and it has been supported by successive State Governments originally funded through Multicultural SA, and then in latter years through DTED.

The meeting was unanimous in their support for the continuation of CITCSA after its 16 year history and asked the Chairman and Executive Manager of CITCSA to undertake negotiations to seek funding for the continuation of the CITCSA Secretariat so that it can continue to provide benefits to the member organisations of CITCSA and South Australia.

Spanish Armada comes to Adelaide

34 business people representing 26 companies from the naval industries in north of Spain, predominantly from the cities of Ferrol and Vigo in the Galicia region, visited Adelaide on Monday September 20th 2010 for a three day visit as part of a five day stay in Australia. The Council for International Trade and Commerce SA (CITCSA) and the Spanish Chamber of Commerce SA in association with the Defence Teaming Centre, the Department of Trade & Economic Development (DTED), Defence SA and the Adelaide City Council, organised the visit to Adelaide.

This visit followed a personally delivered invitation to the Ferrol Chamber of Commerce and the Aclunaga Group from Mr Joaquin Artacho, the Honorary Consul for Spain in South Australia and former President of the Spanish Chamber of Commerce when he undertook a private trip to Ferrol in Spain in March 2010.

The intent of the delegation was to appreciate the importance of the naval auxiliary industry in Spain, particularly the incorporation of these companies with Spain's main ship designer and builder, Navantia that have the contract to build the AWD in SA. The visiting delegates expressed their willingness to form joint venture relationships with SA companies and/or establish themselves as Australian companies to support Australia's shipbuilding into the future.

The itinerary included the following:

- An early morning reception at the Naval, Military and Airforce Club where the group were officially welcomed to South Australia by the Hon Kevin Foley MP, Deputy Premier and Minister for Defence Industries
- A presentation by the Defence Teaming Centre at the Club and business matching meetings with member companies of the Defence Teaming Centre. Over 40 business meetings were held between Spanish companies in the delegation and the 20 South Australian businesses represented.
- A Civic Reception at the Adelaide Town Hall hosted by the Right Honourable Lord Mayor Michael Harbison.
- Morning tea with His Excellency Rear Admiral Kevin Scarce, Governor of South Australia at Government House
- Separate private meetings with Hon Tom Koutsantonis, Minister for Industry and Trade, and Mr Andrew Fletcher, CEO, Defence SA
- Visits to the ASC shipyards and the Governments' new facility "Techport" ship building yards at Osborne.

The delegation from Ferrol was headed by Mr Tomas Casquero, Managing Director of Aclunaga Group of Companies and Mr Miguel Rodríguez Otero, Vice President, Chamber of Commerce of Ferrol.

At least 6 South Australian companies are keen to visit Ferrol in Spain on a trade mission with the Spanish Chamber early in 2011 for further negotiations.
